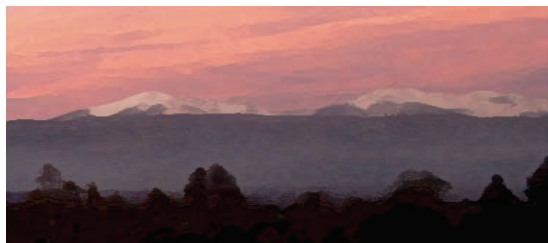
YOUR COMMUNITY FOUNDATION

BECOME A MEMBER OF THE SEELEY LEGACY SOCIETY

The term “planned giving” describes the many ways in which individuals make charitable gifts beyond that which is given for a specific fundraising event or annual cash donation. With careful planning, one can often make a more substantial gift than first expected and can often realize substantial tax benefits in the process. Several ways in which planned giving can be accomplished include:

- Making a bequest to the Foundation in your will or revocable trust.
- Making the Foundation a beneficiary of an IRA or other retirement plan.
- Establishing a charitable gift annuity (several types are possible) designating the charitable distribution to the Foundation.
- Making the Foundation the owner of a paid-up life insurance policy or the beneficiary of a life insurance policy.

While these are the most common ways by which individuals make planned gifts, other forms of giving exist. The Foundation can be creative and flexible in accommodating a donors needs.
